THE SEVENTEENTH RUNNING OF THE CHARLES TOWN CLASSIC (GII) For Three Years Old and Upward. Free Nominations close Friday, August 8, 2025. \$15,000 to enter with a purse of \$1,000,000 Guaranteed. Supplemental Nominations of \$20,000 will be accepted by the time of closing of entries, all fees included. Horses having won a North American, European or Asian Graded or Group stake since August 22, 2023 will have \$15,000 of their entry or supplemental fee refunded upon starting. Entries close Saturday, August 16, 2025 by the usual time of closing. After payment of \$15,000 to the owners of those horses finishing 7th thru last that have not started for a claiming price of \$25,000 or less since August 22, 2024, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Weight: Three Years Old 121 lbs.; Older 124 lbs. Non-winners of a Grade 1 or Group 1 stake in 2025 allowed 3 lbs.; non-winners of a graded or group stake in 2025 allowed 5 lbs. Field will be limited to ten starters with up to four alternates. Preference to North American, European and Asian Graded or Group stake winners since August 22, 2023 in order (Grade 1, then Grade 2, then Grade 3), then to highest earnings in top 4 placings in North American, European and Asian Graded or Group stakes since August 22, 2023, then to highest earnings in top 3 placings in sweepstakes since August 22, 2023, then to highest earnings since August 22, 2023. The Charles Town Classic will run as a lasix free event. Trophy to the winning owner, trainer, and jockey.
