THE SEVENTEENTH RUNNING OF THE CHARLES TOWN OAKS (GII) For Fillies Three Years Old. Free Nominations close Friday, August 8, 2025. \$10,000 to enter with a purse of \$750,000 Guaranteed. Supplemental nominations of \$15,000 will be accepted by the time of closing of entries, all fees included. Horses having won a North American, European or Asian Graded or Group stake will have \$10,000 of their entry or supplemental fee refunded upon starting. Entries close Saturday, August 16, 2025 by the usual time of closing. After payment of \$10,000 to the owners of those horses finishing 7th thru last that have not started for a claiming price of \$25,000 or less, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Weight: 123 lbs. Non-winners of a graded or group stake in 2025 allowed 3 lbs.; non-winners of a sweepstake in 2025 allowed 5 lbs. Field will be limited to ten starters with up to four alternates. Preference to North American, European and Asian Graded or Group stake winners in order (Grade 1, then Grade 2, then Grade 3), then to highest earnings in top 4 placings in North American, European and Asian Graded or Group stakes, then to highest earnings in top 3 placings in sweepstakes, then to highest career earnings. The Charles Town Oaks will run as a lasix free event. Trophy to the winning owner, trainer and jockey.
