\$500,000 (Grade I)

(Up to \$52,000 NYSBFOA)

FOR THREE YEAR OLDS Lasix not allowed within 48 hours of post time pursuant to HISA Rule 4212. By subscription of \$500 each which should accompany the nomination; \$3,500 to pass the entry box and an additional \$4,000 to start. For horses not originally nominated, a supplemental payment of \$4,000 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided accordingly, \$275,000 to the winner, \$100,000 to second, \$60,000 to third, \$30,000 to fourth, \$20,000 to fifth and \$15,000 divided equally amongst the remaining finishers. 124 lbs. Preference to start will be determined by Graded Stakes winners, Graded Stakes placed runners, non-restricted Stakes winners, condition eligibility. Any ties in respective conditions will be broken by total earnings. Starters to be named at the closing time of entries. Trophies will be presented to the winning owner, trainer and jockey. trainer and jockey.
