FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD Lasix not allowed within 48 hours of post time pursuant to HISA Rule 4212. By subscription of \$500 each which should accompany the nomination; \$3,500 to pass the entry box and an additional \$4,000 to start. For horses not originally nominated, a supplemental payment of \$4,000 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided accordingly \$275,000 to the winner, \$100,000 to second, \$60,000 to third, \$30,000 to fourth, \$20,000 to fifth and \$15,000 divided equally amongst the remaining finishers. The Personal Ensign has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Personal Ensign will be entitled to automatic entry into the 2025 running of the Breeders' Cup Distaff Division. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2025 Breeders' Cup Distaff or will receive a credit equal to the 2025 Breeders' Cup Distaff pre-entry and entry fee amount towards any other 2025 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if travelling from a base located outside the state of California. To be eligible for the 2025 Breeders' Cup World Championships held at the Del Mar Thoroughbred Club on October 31st and November 1st, 2025, all horses must be pre-entered by noon (Local Standard Time at the designated place of pre-entry) on Monday, October 20, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out of competition testing by the Horseracing Integrity and Welfare Unit on behalf of the Horseracing Integrity and Safety Authority (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. 124 lbs. Non-winners of a Grade One in 2024-25 allowed 2 lbs.; of a Graded Sweepstakes 2025 allowed 4 lbs. Preference to start will be determined by Graded Stakes winners, Graded Stakes placed runners, non-restricted Stakes winners, condition eligibility. Any ties in respective conditions will be broken by total earnings. Starters to be named at the closing time of entries. Trophies will be presented to the winning owner, trainer and jockey.
