FOR THREE YEAR OLDS AND UPWARD Lasix not allowed within 48 hours of post time pursuant to HISA Rule 4212. By subscription of \$1,000 each which should accompany the nomination. \$7,500 to pass the entry box and an additional \$7,500 to start. For horses not originally nominated, a supplemental nomination fee of \$7,500 in addition to the entry and starting fees may be made at time prior to the closing of entries. The first four finishers from the 2025 Grade Two Suburban will have all fees waived if they start in the 2025 Jockey Club Gold Cup. The purse for the Jockey Club Gold Cup will be divided as follows \$550,000 to the owner of the winner, \$200,000 to the second place finisher, \$120,000 to the third place finisher, \$60,000 to the fourth place finisher, \$40,000 to the fifth place finisher and \$30,000 divided equally amongst the remaining finishers. The Jockey Club Gold Cup has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Jockey Club Gold Cup will be entitled to automatic entry into the 2025 running of the Breeders' Cup Classic Division. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2025 Breeders' Cup Classic or will receive a credit equal to the 2025 Breeders' Cup Classic pre-entry and entry fee amount towards any other 2025 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if travelling from a base located outside the state of California. To be eligible for the 2025 Breeders' Cup World Championships held at the Del Mar Thoroughbred Club on October 31st and November 1st, 2025, all horses must be pre-entered by noon (Local Standard Time at the designated place of pre-entry) on Monday, October 20, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out of competition testing by the Horseracing Integrity and Welfare Unit on behalf of the Horseracing Integrity and Safety Authority (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. Three Year Olds: 122 lbs. Older: 126 lbs. All runners are required to be on the Saratoga grounds by 12:00 pm Thursday, August 28th. The Jockey Club Gold Cup winner is eligible for a bonus from the Japan Racing Association if said winner is selected and runs in the 2025 Champions Cup. Preference to start will be determined by Graded Stakes winners, Graded Stakes placed runners, non-restricted Stakes winners, condition eligibility. Any ties in respective conditions will be broken by total earnings. Starters to be named at the closing time of entries. The New York Racing Association will present a Gold Cup to the winning owner and trophies to the winning trainer and jockey.
