**FOR FILLIES AND MARES FOUR YEAR OLDS AND UPWARD** Lasix not allowed within 48 hours of post time pursuant to HISA Rule 4212. By subscription of \$500 each which should accompany the nomination. \$3,500 to pass the entry box and an additional \$4,000 to start. For horses not originally nominated, a supplemental payment of \$3,500 in addition to the entry and starting fees may be made at any time prior to the closing of entries. 124 lbs. Non-winners of a Grade One in 2025-26 allowed 2 lbs.; of a Graded Sweepstakes in 2025-26 allowed 4 lbs. The 2026 Ogden Phipps Presented by Ford has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the 2026 Ogden Phipps Presented by Ford will be entitled to automatic entry into the 2026 running of the Breeders' Cup Distaff. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2026 Breeders' Cup Distaff or will receive a credit equal to the 2026 Breeders' Cup Distaff pre-entry and entry fee amount towards any other 2026 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the Commonwealth of Kentucky. To be eligible for the 2026 Breeders' Cup World Championships held at Keeneland on October 30 and October 31, 2026, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 19, 2026. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run in full compliance with the Horseracing Integrity and Safety Authority's (HISA) safety and anti-doping and medication control regulations and Breeders' Cup Limited rules, as they may be published and/or amended from time to time, all of which regulations and rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races, and all Challenge winners are subject to out-of-competition testing by the Horseracing Integrity & Welfare Unit on behalf of HISA (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend, or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. Preference to start will be determined by Graded Stakes winners, Graded Stakes placed runners, non-restricted Stakes winners, condition eligibility. Ties to be broken by total earnings. Trophies will be presented to the winning owner, trainer and jockey.
