**FOR FILLIES THREE YEARS OLD** By subscription of \$200 each, which shall accompany the nomination, \$1,500 to enter and \$1,500 to start. Supplemental nominations of \$4,000 will be accepted at time of entry which shall include all other fees due as noted. \$300,000 Guaranteed, of which \$155,000 to the winner, \$55,000 to second, \$32,000 to third, \$21,000 to fourth, \$15,000 to fifth, \$10,000 to sixth, \$7,000 to seventh and \$5,000 to eighth. Weight 122 lbs. Non-Winners of \$90,000 at a mile or over in 2026 allowed 2 lbs., \$45,000 at a mile or over in 2026, 4 lbs. (Maiden, claiming and starter races not considered in estimating allowances). Starters to pass the entry box by the usual time of closing. Field limited to 14 starters. First preference to Graded Stakes winners in 2026. Second preference to horses which have accumulated the highest total earnings. Trophy to the winning owner, trainer and jockey.
