ENTRY AND START FEES WILL BE WAIVED FOR ANY HORSE THAT HAS WON A GRADED STAKE IN 2026. \$300,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$6,000 TO ENTER AND START. Weights: Monday, June 29th. Starters to be named through the entry-box by the usual time of closing. This race will not be divided and if the entry number exceeds fourteen (14), preference will be given to Breeders' Cup nominees only of equal weight assignment, then highest 2025-2026 earnings. Different owners will have equal draw according to weights. Failure to draw into the race cancels all fees.
