Non-winners of a Grade 1 stakes at a mile or over in 2026, 3 lbs. Preference by graded stakes earnings. Maximum of 14 starters. The NYRA Bets Haskell Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the NYRA Bets Haskell Stakes will be entitled to automatic entry into the 2026 running of the Breeders' Cup Classic Championship race and will be entitled to have pre-entry and entries fees waived for the Championship race and receive a travel award if shipping from a base located outside the Commonwealth of Kentucky. Furosemide (Lasix) is not permitted within 48 hours of post time for this race. The winning owner to receive a trophy.
