Non-winners of a Grade One or Two in 2025-26 allowed 2 lbs.; of a Sweepstakes in 2026 allowed 4 lbs. Preference to be assigned in the following order: Graded Stakes winners (in order I-II-III), Graded Stakes placed runners (in order I-II-III), non-restricted Stakes winners, condition eligibility. Ties to be broken by highest total earnings. A trophy will be presented to the winning owner.
