Supplementary nominations may be made at time of entry by a payment of \$5,000, which includes all fees. The winner to receive \$90,000; \$30,000 to second; \$15,000 to third; \$7,500 to fourth; \$5,000 to fifth; \$2,500 sixth through last. Weights: 3-year-olds, 121 lbs.; Older, 124 lbs. Non-winners of a graded stakes in 2026 allowed 2 lbs.; a stakes in 2026 allowed 4 lbs.; \$50,000 once in 2026 allowed 6 lbs. The Philip H. Iselin Stakes has been selected as one of the Breeders' Cup Dirt Dozen Races for the \$1 Million Breeders' Cup Dirt Mile. The nominated winner of The Philip H. Iselin Stakes will receive a credit of \$15,000 toward entry fees into the 2026 Grade I Breeders' Cup Dirt Mile, 2nd place will receive a \$7,500 credit toward the Dirt Mile entry fees and 3rd place will receive \$3,750 credit toward the Dirt Mile entry fees. Furosemide (Lasix) is not permitted within 48 hours of post time for this race. The winning owner to receive a trophy.
