THE EIGHTEENTH RUNNING OF THE CHARLES TOWN CLASSIC (GII) For Three Years Old and Upward. Free Nominations close Friday, August 14, 2026. \$15,000 to enter with a purse of \$1,000,000 Guaranteed. Supplemental Nominations of \$20,000 will be accepted by the time of closing of entries, all fees included. Horses having won a North American, European or Asian Graded or Group I or II stake since August 28, 2024 will have \$15,000 of their entry or supplemental fee refunded upon starting. Entries close Saturday, August 22, 2026 by the usual time of closing. After payment of \$15,000 to the owners of those horses finishing 7th thru last that have not started for a claiming price of \$25,000 or less since August 28, 2025, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Weight: Three Years Old 122 lbs.: Older 126 lbs. Non-winners of a Grade 1 or Group 1 stake since February 28 allowed 2 lbs.; non-winners of a graded or group stake in 2026 allowed 4 lbs. Field will be limited to ten starters with up to four alternates. Preference to North American, European and Asian Graded or Group stake winners since August 28, 2024 in order (Grade 1, then Grade 2, then Grade 3), then to highest earnings in top 3 placings in North American, European and Asian Graded or Group stakes since August 28, 2024, then to highest earnings in top 3 placings in sweepstakes since August 28, 2024, then to highest earnings since August 28, 2024. THE CHARLES TOWN CLASSIC WILL RUN AS A LASIX FREE EVENT. Trophy to the winning owner, trainer, and jockey.
