Preference to be assigned in the following order: Graded Stakes winners (in order I-II-III), Graded Stakes placed runners (in order I-II-III), non-restricted Stakes winners, condition eligibility. Ties to be broken by highest career earnings. All runners are required to be on the Saratoga Grounds by 12:00 pm Wednesday, August 26th. Trophies will be presented to the winning owner, trainer and jockey.
