Weights: Colts and Geldings, 124 lbs.; Fillies, 121 lbs. Non-winners of \$50,000 allowed 2 lbs.; \$30,000 other than auction race or claiming 4 lbs. **STARTERS TO BE NAMED THROUGH THE ENTRY BOX WEDNESDAY, SEPTEMBER 2 BY THE CLOSING TIME OF ENTRIES.** High weights preferred. Total non-claiming purse earnings will determine the order of preference for horses of equal status. The Del Mar Futurity has been selected as a Breeders' Cup Dirt Dozen Bonus Series Race for the \$2 million Breeders' Cup Juvenile on October 30, 2026 at Keeneland. The nominated winner of the Del Mar Futurity will receive a credit of \$30,000 toward entry fees into the 2026 Breeders' Cup Juvenile, 2nd place will receive a \$15,000 credit toward entry fees and 3rd place will receive \$7,500 credit toward entry fees. A trophy will be presented to the winning owner.
