FOR THREE YEAR OLDS AND UPWARD Lasix not allowed within 48 hours of post time, pursuant to HISA Rule 4212. By subscription of \$250 each which should accompany the nomination; \$1,250 to pass the entry box and an additional \$1,250 to start. For horses not originally nominated, a supplemental nomination payment of \$1,250 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The Vosburgh has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Vosburgh will be entitled to automatic entry into the 2026 running of the Breeders' Cup Sprint Division, nominated winner will also be entitled to have pre-entry and entry fees waived for the 2026 Breeders' Cup Sprint or will receive a credit equal to the 2026 Breeders' Cup Sprint pre-entry and entry fee amount towards any other Breeders' Cup Championship race, and all horses will be entitled to receive a travel stipend if travelling from a base located outside the state of Kentucky. To be eligible for the 2026 Breeders' Cup World Championships held at Keeneland Race Course on October 30th and 31st, 2026, all horses must be pre-entered by noon (Local Standard Time at the designated place of pre-entry) on Monday, October 19, 2026. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published from time to time. All runners nominated and all Challenge winners are subject to out-of-competition testing conducted by the Horseracing Integrity and Welfare Unit on behalf of the Horseracing Integrity and Safety Authority (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. Three Year Olds: 123 lbs. Older: 126 lbs. Preference to start will be determined by Graded Stakes winners (in order I, II, III), Graded Stakes placed runners (in order I, II, III), non-restricted Stakes winners, condition eligibility. Ties to be broken by highest total earnings. Trophies will be presented to the winning owner, trainer and jockey.
