First Five Finishers Earn Points For The Road To The Kentucky Derby
\$250,000 Guaranteed
(Includes \$50,000 TBD/HBPA/FL Fund)**

FOR THREE YEARS OLD Free nominations. \$850 to pass the entry box and \$850 additional to start with \$250,000 Guaranteed, (which includes \$50,000 TBD/HBPA FL Funds for Registered Florida Breds, which shall be distributed 70% to the winner, 20% to second and 10% to third.) For those not eligible for Florida monies the winning owner to receive 60%, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth of the \$200,000 open money. Weight: 122 lbs. Starters and riders to be named through the entry box by the usual time of closing. This field will be limited to twelve starters. In the event more than twelve pass through the entry box, the twelve starters will be determined with preference given to Grade I, II or III Stakes winners in that order, then those that have accumulated the highest career earnings. For those that enter and are eliminated under these conditions, the entry fee will be refunded. SUPPLEMENTARY NOMINATIONS OF \$3,000 EACH (which include entry and starting fees) DUE BY THE USUAL TIME OF CLOSING. Same owner entry may run to the exclusion of a single entry. IMPORTANT REMINDER: Certain finishing positions in this race will earn points to qualify for the 2026 Kentucky Derby, pursuant to the official rules for The Road to the Kentucky Derby published by Churchill Downs Incorporated. For Three Years Old under International Medication Protocol. Horses entered to compete shall not be eligible to run on furosemide less than (24) hours prior to post time for the race.
