Late Supplemental Nominations of \$10,000 at time of entry Sunday February 8, 2026. Horses starting in The Riley Allison Derby, their entry fee will be \$2,500.00. First preference will be preferred by lifetime graded earnings. Second preference by lifetime earnings. Weights: Colts-Geldings 123 lbs. Fillies 118 lbs. Certain finishing positions in this race will earn points to qualify for the 2025 Kentucky Derby, pursuant to the official rules for The Road To the Kentucky Derby published by Churchill Downs Incorporated. The winner of The Sunland Park Derby will be awarded 20 points, the second place finisher 10 points, the third place finisher 6 points, the fourth place finisher 4 points, the fifth place finisher 2 points. Starters to be named through the entry box at the usual time of closing. First preference: lifetime earnings in graded stakes, second preference, highest lifetime earnings. This race will be limited to twelve starters. A suitable award will be presented to the winning owner. After payment of 1% to all owners finishing sixth through last, The remaining purse will be distributed as follows, 60% to the winner, 22% to second, 10% to third, 5% to fourth, 3% to fifth.
