



2nd Running Of THE VIRGINIA DERBY A Road to the Kentucky Derby Points Race \$500,000

FOR THREE-YEAR-OLDS Colts and Geldings 123 lbs.; Fillies 118 lbs. No nomination fee; \$2,500 to enter and \$2,500 additional to start. Supplementary nominations may be made at the time of entry on Saturday, March 7, 2026, by payment of \$10,000 each (includes all fees). \$500,000 Guaranteed, plus Road To The Kentucky Derby Points to horses finishing first through fifth. 60% of the purse shall be paid to the owner of the winner plus 50 Road To The Kentucky Derby Points, 20% to second plus 25 Road To The Kentucky Derby Points, 11% to third plus 15 Road To The Kentucky Derby Points, 6% to fourth plus 10 Road To The Kentucky Derby Points, 3% to fifth plus 5 Road To The Kentucky Derby Points. The maximum number of starters for the Virginia Derby will be fourteen starters with two also eligibles. In the event more than fourteen pass the entry box, the fourteen starters will be determined with preference given to: Graded /Group Stakes winners in order (I-II-III), Graded/Group Placed (2nd then 3rd, in order I-II-III), open stakes winners, then highest career earnings. Starters and riders must be named through the entry box by the usual time of closing. Failure to draw into the race will cancel all fees. A trophy will be presented to the the winning owner.
