**FOR THREE YEAR OLDS** Lasix not allowed within 48 hours of post time pursuant to HISA Rule 4212. By subscription of \$750 each which should accompany the nominations; \$5,625 to pass the entry box and an additional \$5,625 to start. For horses not originally nominated, a supplemental nomination payment of \$5,625 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The winner of the 2026 Wood Memorial "Presented by Resorts World Casino" and the first three finishers of the 2026 Peter Pan stakes on May 9th will have their entry and starting fees waived for the 2026 Belmont Stakes to be run at the Belmont Stakes Racing Festival in Saratoga on Saturday, June 6th. The purse will be divided \$400,000 to the owner of the winner, \$140,000 to the second-place finisher, \$75,000 to the third-place finisher, \$50,000 to the fourth-place finisher, \$30,000 to the fifth place-finisher, \$22,500 to the sixth-place finisher, \$17,500 to the seventh-place finisher and \$15,000 to the eighth-place finisher. Certain finishing positions in this race will earn points to qualify for the 2026 Kentucky Derby, pursuant to the official rules for the Road to the Kentucky Derby, published by Churchill Downs Incorporated. The winner of the Wood Memorial will be awarded 100 points, the second-place finisher 50 points, the third-place finisher 25 points, the fourth-place finisher 15 points and the fifth-place finisher 10 points. 123 lbs. Preference will be given in the following order: Grade One winners; Grade One placed runners; Grade Two winners; Grade Three winners; Total earnings. A trophy will be presented to the winning owner.
